Conditions of Entry

1. Pre-entries will be accepted through online registration via HorseShowsOnline.com.
2. Entry deadline is Wednesday June 16, 2021. Post entries will be charged a late fee of \$30.00 per horse per rider. Please have proof of negative Coggins. We only accept cash and checks.
3. Fees:
  - a. Class Fee: \$15 each for AHJA recognized; Best Turnout: \$3 (must have armband)
  - b. Late Entry Fee: \$30 per horse per rider
  - c. AHJA Non-Member Fee: \$10 per rider
  - d. AHJA Office Fee: \$10 per horse per rider
  - e. Day Pens Only: \$35 – Contact Guerry Force – (205)381-0364
    - i. Day pens are available at 7:30 am on Saturday June 19<sup>th</sup> – no exceptions
  - f. Paramedic: \$10 per rider
4. Hard hats must be worn at all times while mounted, including schooling. All riders must wear ASTM-approved helmets. Appropriate jumper attire required.
5. The management reserves the right to refuse, accept conditionally, or cancel any entries, disqualify exhibitors, prohibit showing of entries and cancel/edit awards of prizes without claims or damages. Management reserves the right to cancel any classes due to weather.
6. Current AHJA rules will be available at the show secretary's desk.
7. NO WARM UP ROUNDS
8. Open schooling will be allowed until 30 minutes prior to the ring's start time. We will drag the ring before the first class. Schooling will be available Friday June 18th from 1:00 pm -6:00 pm in show ring.
9. Lunging allowed in ring 4 only.
10. ALL dogs must be on a leash at all times.
11. Veterinarian on call: Coosa Valley Equine (205)753-0451
12. Farrier on Call: Mauricio Barrios (205)381-0364
13. Six ribbons will be awarded in all AHJA recognized classes. A first-place prize will also be awarded.
14. Show will be held in fenced sand arena.
15. Attire – traditional jumper attire is allowed in accordance with the AHJA rule book.
16. Horses will not be excused from showing without a veterinarian's certificate showing illness or incapacity of mount. This must be received by the show secretary by the end of the show.
17. All scratches and adds must be done at the secretary's desk and proof of scratch/add must be taken to the in gate. No adds or scratches at the gate.
18. Concessions will be provided.
19. **BEST TURNOUT Class 200:** \$3 Open to all exhibitors in any class. This award will be presented to the rider who best displays appropriate and proper turnout in regards to both themselves and their mount during the show day. Award will be given out at judge's discretion. Riders must display a colored dot on their show number to be considered for this award. Dot stickers will be given out by the show secretary. Class not recognized by the AHJA.

### **WAIVER AND RELEASE OF LIABILITY**

For and in consideration of the AHJA's acceptance of my entry, and allowing me, the undersigned, or my minor child, to participate in any capacity in an AHJA sanctioned or approved event or activity ("AHJA-sponsored event"), including but not limited to equestrian shows, competitions, clinics, practices and related or incidental activities and events, and Fox Lake Farm Inc., I, for my myself, and on behalf of my spouse, children, heirs, executors and administrators, next of kin, successors and assigns, hereby agree as follows:

- B. **ACKNOWLEDGMENT AND ASSUMPTION OF RISK:** I knowingly, willingly and voluntarily acknowledge the inherent risks associated with equestrian sports, and know that horseback riding and related equestrian activities are inherently dangerous, and that any AHJA-sponsored event involves risks and dangers, including, without limitation, the potential for serious bodily injury, sickness and disease, including communicable diseases among humans or animals, trauma, pain and suffering, bites, kicks, abrasions, contusions or other injury or disability, allergic reactions, falls, paralysis, death, loss or damage to personal property, including without limitation to trailers, vehicles, tack, equipment, horses or other animals, and other unknown risks and dangers.

I specifically acknowledge that Alabama and the United States is currently battling the pandemic associated with COVID-19, a highly transmissible infectious disease, and agree that I will comply with any and all safety measures and social distancing protocols instituted by the AHJA and the AHJA-sponsored event, and further agree that I knowingly, willingly and voluntarily acknowledge and assume and take sole responsibility for the risks associated with participating in AHJA-sponsored events during the COVID-19 pandemic and its aftermath.
