CONDITIONS OF ENTRY

RULES AND GENERAL INFORMATION - In all classes wherein the rules of the sanctioning association(s) do(es) not apply, Management shall settle any dispute or question that may arise and its decision shall be final. Management reserves the right to refuse, accept conditionally, or to cancel entries, disqualify riders or exhibitors, prohibit exhibition or entries, and cancel or combine classes, or to reschedule classes, to change rings or rotate judges; and to change specifications in classes. Management may designate a jumping order, use THE ONE MINUTE RULE, and/or use a "dotted line".

REGISTRATION INFORMATION - 1) Online entry information and a complete description of divisions and cross entering information, please visit www.horseshowsonline.com. 2) Owners and exhibitors are responsible for all horses and fees incurred by them or their agents, even though payment may not be submitted along with entry 3) Pre-entry deadline is Wednesday, April 7, 2021. All entries received after said date will be treated as post-entries and charged a late entry fee. NO EXCEPTIONS. 4) AHJA Membership forms are available online and at the show secretary's desk.

BACK NUMBERS: Numbers will be issued only when entries have all necessary signatures, information is complete with proper credentials provided and when an open check has been provided (if credit card is not vaulted).

PROTECTIVE HEADGEAR - ASTM/SEI approved helmets must be worn at all times for all riders on horseback, regardless of age.

MEDICAL SERVICES - Medical Center Services are available.

MINOR EXHIBITORS - Parent(s) or guardian(s) of a minor child shall hold the horse show management and the facility harmless for any injury to such minor. No minor child's entry will be accepted or number issued unless entry is signed by a parent or LEGAL guardian. The signature of unrelated persons will not be accepted. Parents must sign online release upon checking in with the show secretary.

TROPHIES & RIBBONS - Every AHJA class offered herein will be awarded six ribbons. The Walk/Trot and Crosspole Divisions will be awarded 10 ribbons.

CHAMPION AND RESERVE - Awarded based on 10,6,4,3,2,1.5 in divisions with at least three classes, including Jumpers.

MEASUREMENT - Entries for the Pony divisions must present a valid USEF or AHJA card or be measured before showing. DISCOURTESY - To any Show Official by any owner, rider, trainer, handler or groom will disqualify any horses with which they are associated and fees for horses forfeited.

STALLS AND BEDDING – 30 temporary 10x10 stalls are available the day before the show. Stalls will be assigned upon completion of arrangements with the Stable Manager, Ashley Morrison. TEXT at 205.799.2999 for stall and shavings reservations by Monday, April 5, 2021 by 6:00 pm.

SCHOOLING - In designated areas only. Open schooling is allowed Friday, April 9th until 7pm in Ring 1 and until 7pm in Ring 2 and, April 10th, 30 minutes prior to the arena start times.

MOTORIZED VEHICLES, dirt bikes, golf carts. Only licensed drivers allowed to drive any motor vehicle.

CONCESSIONS - will be available on the Show Grounds provided by a Mexican Food Truck - DOGS - Must be leashed and under control of the owner or dog may be impounded.

COGGINS TEST - Negative certificates dated within 1 year are required for admittance with state and local laws. WASHING - Washing and bathing of horses to be done in designated wash rack.

CLASS SPECIFICATIONS – All classes will be conducted in accordance with the AHJA Rulebook

RETURNED CHECKS AND DECLINED CREDIT CARDS – a \$50 fee will be charged for returned checks for each time deposited, WITH NO EXCEPTIONS. All returned checks must be honored within 21 days of notification. A \$50 fee will be charged to all declined credit cards each time processed, WITH NO EXCEPTIONS. All declined cards must be honored within 21 days of notification.

REFUND POLICY – Office, Stall (NO STALL FEES WILL BE REFUNDED), and shavings fees will not be refunded under ANY circumstances. Entry fees will not be refunded unless a certificate of illness or injury prepared by an accredited veterinarian is presented to the secretary before the start of the show. Once the show has started, horse that are not shown in classes which they have entered forfeit their entry fees, except if a horse is injured or becomes ill prior to the class or classes entered. Proper notification of the scratch must be made in the show office BEFORE the start of the class or classes being scratched. This must be accompanied by a certificate from the official horse show veterinarian. It is the exhibitor's responsibility to bring the yellow copy of the scratch form to the show ring, to finalize the scratch process. In either case above the entry fees will be refunded less the office fee of \$30. Refunds of entry fees will not be given in the event a class or classes, or all or part of the competition is cancelled due to severe weather, an accident, an emergency or some other act of God. Refunds of stall fees, office fees, shavings fees will not be given, however, class fees will be refunded in the event of cancellation of all or part of the competition due to severe weather, an accident, an emergency, or some other act of God.

CHECK OUT- Any disputes found on your printed invoice, must be resolved within 24 hours. Please review bills carefully. If disputes are not negotiated within this time period, the invoice will stand. Any open invoices left in the office after the end of the show will be closed out with the method of payment holding the entry.

DISPUTES – In all classes, Show Steward and Show Management will settle any disputes, conflicts or questions that may arise and their decision shall be final.

Helmets Must Be Worn At All Times When Mounted. The Sanctioning Associations encourage all riders wear protective headgear passing or surpassing current ASTM/ SEI standards with harness secured while riding anywhere on the show grounds. It is the responsibility of the rider, parents, guardian, or trainer of the junior exhibitor to see to that the headgear worn complies with appropriate safety standards and is properly fitted and in good condition. All riders must wear ASTM/SEI Approved helmets with properly adjusted (snug) harness.

Due to the recent outbreak of COVID-19 the Alabama Hunter Jumper Association will be taking extra precautions for the remainder of the 2020 show season. Anyone choosing to attend an AHJA recognized show is coming at their own risk and by attending you are taking sole responsibility for yourself and anyone under your

supervision.

1. To receive admittance to any AHJA sanctioned horse show exhibitors, trainers, grooms, horse show officials, guardians, and essential personnel, etc. must:
 - a. Not have anyone in their household test positive for COVID-19 in the last 14 days.
 - b. Not been advised by any healthcare professional to self-quarantine nor has been in contact with someone who has test positive for COVID-19 in the last 14 days.
 - c. Not shown any symptoms of COVID-19 in the last 24-48 hours. Symptoms include, but are not

limited to, a fever over 100.4, cough, or shortness of breath.

- d. Must be willing to adhere to all policies implemented by the AHJA and additional policies implemented by the host farm. Any person found not in accordance may be asked to leave or wait in their car by the show managers, show steward, show secretary, or AHJA president.
2. Anyone on property must maintain “social distancing” and keep 6’ of space between themselves and others in accordance with federal, state and local guidelines.
3. Any vehicle or trailer is subject to inspection to ensure that only the necessary parties are admitted.
4. NO outside spectators are allowed.
5. Horse Show Office Procedures
 - a. There will be one representative per farm/trainer. This representative will be the only one allowed in the show office per farm/trainer.
 - b. This representative will be responsible for collecting payments (checks or cash) from all clients from the same barn or trainer and turn in payment to the secretaries in exchange for back numbers. Those paying in cash must use the prize list to calculate their total. Cash must be turned in at the beginning of the day.
 - c. Secretaries will email all receipts to the trainers listed on the entry. Trainers are responsible for distributing receipts.
 - d. Only one person will be allowed in the show office at a time.
 - e. Adds and scratches will need to be done online – this will be open until 8:00 pm the night before.
6. Trainers are responsible for making sure their customers and additional personnel adhere to all rules. By coming to the horse show they are taking responsibility of their clients and will be held liable for any action not in accordance with these guidelines. Before entering the show grounds, they need to review the new policies with all persons coming under their supervision.
7. Wearing a facemask is recommended at all times when not mounted, and exhibitors will not be penalized for wearing facemasks during their rounds..
8. When lining up for under saddler/equation on the flat classes riders need to maintain 6’ between themselves and all other competitors
9. You are not permitted to allow social gatherings of 10 or more persons, parties, or in-show events.
10. Show staff will sanitize common spaces throughout the day. These spaces include, but not limited to: port-o-lets, bathroom facilities, door knobs, schooling jumps, wash stalls, community watering spickets, in-gate and ribbon tables, course boards, and any other “high traffic” area.
11. Hand washing or sanitization stations will be available on property. However, it is recommended that attendees bring their own supplies as well.
12. **WARNING:** In this unprecedented time of the COVID-19 pandemic, the Alabama Hunter Jumper Association and (insert show name here) are committed to providing the safest and cleanest

show facilities and events as reasonably possible, but make no representations or guarantees in that regard. By participating in or attending this AHJA-sponsored event, an attendee acknowledges and assumes any and all risks relating to COVID-19, or any other communicable disease, and takes sole responsibility for him- or herself, his or her spouse and children, other family and guests for such risks of infection, and releases and holds harmless the AHJA from any and all liability associated with same. In addition, by participating or attending an AHJA-sponsored event, each attendee agrees to be bound and to follow any applicable federal, state, local, AHJA, or AHJA-sponsored event safety guidelines and/or social distancing protocols.

WAIVER AND RELEASE OF LIABILITY

For and in consideration of the AHJA's acceptance of my entry, and allowing me, the undersigned, or my minor child, to participate in any capacity in an AHJA sanctioned or approved event or activity (“AHJA-sponsored event”), including but not limited to equestrian shows, competitions, clinics, practices and related or incidental activities and events, and _____ (insert specific AHJA-sponsored event), I, for my myself, and on behalf of my spouse, children, heirs, executors and administrators, next of kin, successors and assigns, hereby agree as follows:

1. **AHJA RULES AND POLICIES:** I agree to be bound and to abide by the rules and policies of the AHJA as published on its website at www.alabamahunterjumpers.org, and as amended periodically.
2. **ACKNOWLEDGMENT AND ASSUMPTION OF RISK:** I knowingly, willingly and voluntarily acknowledge the inherent risks associated with equestrian sports, and know that horseback riding and related equestrian activities are inherently dangerous, and that any AHJA- sponsored event involves risks and dangers, including, without limitation, the potential for serious bodily injury, sickness and disease, including communicable diseases among humans or animals, trauma, pain and suffering, bites, kicks, abrasions, contusions or other injury or disability, allergic reactions, falls, paralysis, death, loss or damage to personal property, including without limitation to trailers, vehicles, tack, equipment, horses or other animals, and other unknown risks and dangers.

I specifically acknowledge that Alabama and the United States is currently battling the pandemic associated with COVID-19, a highly transmissible infectious disease, and agree that I will comply with any and all safety measures and social distancing protocols instituted by the AHJA and the AHJA-sponsored event, and further agree that I knowingly, willingly and voluntarily acknowledge and assume and take sole responsibility for the risks associated with participating in AHJA-sponsored events during the COVID-19 pandemic and its aftermath.
